Unlawful Carrying Weapon – Misdemeanor A PC 46.02.03 (a)(1)(2)(a-1)(1)(2)(A)

My belief of the foregoing statement is based upon the following information:

Affiant, Joseph Townes #231 is a commissioned Peace Officer in the State of Texas and has been since November, 2008. Affiant is currently employed by the City of Pflugerville and is assigned to the Patrol Division.

Belief of the foregoing statement is based upon the following information.

On Sunday, December 30th, 2018 at approximately 15:36 hours, I responded to Chisolm Point Complex located at 900 Broken Feather Trail #112 Pflugerville, Travis County, TX 78660 in reference to an active burglary of a habitation. While in route, Pflugerville Dispatcher advised the caller lived at lot #115 and viewed four males enter the residence directly behind the caller's residence. Upon arrival, officers were able to determine the four males entered lot #112.

The males would voluntarily come out of lot #112 while officer's set up perimeter around #112. All four males were detained and given their Miranda Warning. Officer's searched Cardenas for officer safety reasons and due to him smelling like marijuana. On Cardenas person he had a useable amount of green leafy substance from which my law enforcement experience I knew to be marijuana. Also, on Cardenas person was approximately \$2090.00 in US Currency located in his pants pockets. I inquired if Cardenas had a job and he advised me, "I have a temp job. That is hard earned money." I asked Cardenas if his vehicle was around the area and he advised me his mother dropped him off. I observed Cardenas with a lanyard with a key fob around his neck with what appeared to be a GMC key for a GMC type of vehicle. I advised Cardenas, he was being deceitful with me and I informed Cardenas I believed his car was in the complex not far from our location. At this time Cardenas became very nervous. From my experience working this particular area I knew there to be a parking lot just north of my location in relation to lot #112. I advised Cardenas, if I located a vehicle that worked with the key fob and key on his lanyard he would have some explaining to do. Cardenas stated something to the effect, if you do find a vehicle I do not give you permission to search it.

I searched the parking lot just north of lot #112 and located a Blue GMC Arcadia, bearing a TX paper plate identified as 22768Y9, VIN: 1GKER23D09J148943. I pressed the lock, unlock and panic button on the key fob and all buttons activated the Blue GMC Arcadia bearing TX paper plate 22768Y9. I walked up to the vehicles driver side door and immediately observed a firearm in the middle console in plain view. Next to the firearm was a bottle of Promethazine. At that time the vehicle was detained for narcotics investigation.

I returned back to lot #112 and Cardenas appeared to be defeated with his expression. I asked Cardenas about the vehicle and he informed me he was visiting some female friends that live in the complex. Cardenas admitted the firearm and promethazine were his. Cardenas stated he purchased the firearm at a pawn shop for the protection of his family. I inquired if there was anything else in the vehicle and Cardenas took a deep breath and advised me there was Xanax (Alprazolam) and XO's (XO is a street name for ecstasy otherwise known as its scientific name 3,4-methyl enedioxy methamphetamine-MDMA). Cardenas stated the Xanax
