**PROBABLE CAUSE AFFIDAVIT FOR WARRANT OF ARREST AND DETENTION**

The undersigned Affiant, who after being duly sworn by me, on oath, makes the following statement:

I have good reason to believe and do believe that PATRICIA CRYSTAL GARCIA – WHITE FEMALE – DATE OF BIRTH 12/24/1989 – TEXAS DRIVER'S LICENSE 22910491 – TEXAS IDENTIFICATION CARD 26386006 on or about the 11TH day of JULY, 2019, did commit the offense of Possession of a Controlled Substance in Penalty Group 1 (Methamphetamine) – Four Grams or More but Less than 200 Grams – Second Degree Felony – Texas Health and Safety Code 481.115(d).

Belief of the foregoing statement is based upon the following information.

AFFIANT, SERGEANT JARED THYSSEN #196, IS A COMMISSIONED PEACE OFFICER FOR THE CITY OF PFLUGERVILLE AND HAS BEEN SO SINCE SEPTEMBER OF 2007. AFFIANT IS CURRENTLY ASSIGNED TO THE PATROL DIVISION.

On 7/11/19 at about 0003hrs I was on patrol in a fully marked Pflugerville Police Vehicle while in full police uniform. I was driving south through about the 1000 blk of Immanuel between that roadway's intersections with Pigeon Forge and Wells Branch. This portion of the roadway is located in Travis County, Texas and it is my understanding that parts of this stretch of roadway are within the City of Pflugerville and some are not. A large portion of the surrounding land and neighborhoods, however, are within the City of Pflugerville and I frequently use this roadway to travel to other portions of the City of Pflugerville to fulfil my duties. During this time, I observed a silver Dodge four door bearing Texas Temporary License Plate 39070V8 along the west side of the roadway facing south. The vehicle had its hazard lights flashing and a portion of the vehicle was obstructing the southbound lane of traffic along this two lane roadway. It appeared the back left tire of the vehicle was also off of the ground and that portions of the front and passenger side of the vehicle had run off the roadway into the grass along the west side of the roadway. I also noted the vehicle's headlights were on as I made contact with the sole occupant of the vehicle who was seated in the driver's seat - PATRICIA GARCIA – WHITE FEMALE – DATE OF BIRTH 12/24/89.

Patricia admitted to driving the vehicle and indicated she had struck a curb north of our location. I observed a glass "Dos XX" beer bottle in the back seat pocket of the front passenger seat and was able to detect what I believed to be the odor of an alcoholic beverage emanating from the vehicle at times. I examined the passenger side of the vehicle and saw disabling damage to the front right and rear right tires. I later checked north of our location and it appeared Patricia struck a curb on the southern driveway of 1010 Immanuel. I saw markings and a tire track on the roadway that led from this collision location to where Patricia's vehicle came to a stop. It should be noted that the vehicle is also registered to Patricia Garcia.

During the course of this investigation I learned that both Patricia's Texas Driver's License, which had expired in 2006, and her Texas Identification Card were both "Not Eligible" indicating Patricia was Driving While License Invalid. Patricia's Driver's license listed the following active suspension:

Suspension – Drug Education Program Required – Begin 3/21/17 – End 12/31/9999

Patricia's Texas Identification Card listed the following active revocation related to the operation of a motor vehicle while intoxicated:

Revoked – Failure to Complete DWI Education Program – Begin – 10/11/14 – End – 12/31/9999

Patricia's Texas Identification Card listed the following convictions for Driving While License Invalid:

Offense Date – 10/29/09 – Conviction Date – 11/13/2014 – Offense Location – Austin, Texas

Offense Date – 12/2/09 – Conviction Date – 11/13/2014 – Offense Location – Austin, Texas

Based on the above information Probable Cause was developed to arrest Patricia for Driving While License Invalid and enhance the offense to a Class B Misdemeanor.

I decided to cause Patricia's vehicle to be towed from the scene as it was partially blocking a lane of traffic and nobody was present to take possession of it. A vehicle stopped on scene briefly and Patricia stated the subject was her husband but he departed prior to making contact with officers. Patricia's vehicle was also inoperable due to the damage to the passenger side tires. Per Pflugerville Police Department Policy an inventory was conducted of the vehicle. During this inventory a large purse was located in the trunk of the vehicle containing a wallet with Patricia's Texas Offender Identification Card along with a paper copy of a temporary Texas Identification Card issued to Patricia.

Inside of this purse, in plain view upon opening the trunk, I saw a plastic container containing a large amount of a white crystalline substance I recognized through my training and experience as a police officer to be methamphetamine. A separate plastic container was located containing several small plastic baggies containing additional white crystalline substance believed to be methamphetamine. These baggies appeared to be packaged for individual sale and further search of the possessions in the trunk revealed a large amount of empty small baggies and two scales with what appeared to be narcotics residue on them. A presumptive "NIK Kit" test battery of some of the crystalline substance found in one of the individually packaged bags resulted in a positive indication for methamphetamine. The white crystalline substances were later weighed at the Pflugerville Police Department and found to be approximately 116 grams in aggregate.

Also located among the possessions in the trunk were two separate packages containing a brown, tarry like substance that smelled of vinegar. It is through my training and experience as a police officer that I believe this substance to be "black tar heroin" but further testing will be sought to identify the substance.

A small bag containing a green leafy substance I believe to be marijuana based upon my training and experience as a police officer was located in the plastic container with the individually packaged bags of methamphetamine. Also in the plastic container with the individually packaged bags of methamphetamine was a small plastic bag containing two whole pills and a partial pill. One pill was a round white medication marked "319" that is believed to be Tramadol Hydrochloride based on information from "www.drugs.com." Tramadol is listed in Penalty Group 3 of Texas Health and Safety Code 481. Also located in this baggie was an orange round pill marked "1" over "2" believed to be Clonazepam based on information from "www.drugs.com." Clonazepam is listed in Penalty Group 3 of Texas Health and Safety Code. Also located in the trunk were eight bar shaped pills marked "S903," which is believed to be Alprazolam based on information obtained from "www.drugs.com." This medication is also listed in Penalty Group 3 of Texas Health and Safety Code 481.

Based on the packaging of the pills I did not believe Patricia was in lawful possession of them as no prescription information was present and they were packaged among other illicit materials in a manner that is commonly associated with narcotics distribution. During this investigation Pflugerville Police Officer J. James #308 conducted an impaired driver investigation to see if Patricia was safe to drive. He later told me during his investigation Patricia indicated that she takes no prescription medications.

Also located among Patricia's belongings was a small notebook that appeared to be used to keep track of money owed from other subjects and I believed this item to be a ledger used to keep track of narcotics debts. Multiple syringes, which are commonly used for the consumption of narcotics such as heroin and methamphetamine, were found among the possessions in the trunk. Because on the items located in the vehicle I believe, per my law enforcement training and experience, that Patricia is an illicit narcotics distributor.

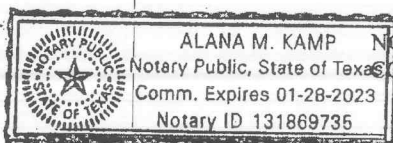
It is my belief that Patricia did intentionally and knowingly possess a substance in Penalty Group 1 to wit -- Methamphetamine. The substance weighed about 116 grams thereby making this offense a second degree felony.
